



THE BOROUGH OF REDCAR AND CLEVELAND SAFER STREETS SCHEME TRAFFIC CALMING NOTICE 2023

In accordance with Section 90C of the Highways Act 1980, the Council hereby give notice of its proposals to introduce traffic calming schemes as specified in the schedules below .

1. The location of the new round top road humps as given in Schedule 1 shall be on the roads shown and in the positions shown in Schedule 1. The approximate dimensions of the proposed road humps are 75 millimetres in height, and 4 metres in length.
2. The location of the new speed cushions as given in Schedule 2 shall be on the roads shown and in the positions shown in Schedule 2. The approximate dimensions are 75 millimetres in height, 1.7 metres wide and 3.0 metres in length.
3. The location of the new flat top road humps as given in Schedule 3 shall be on the roads and in the positions shown in Schedule 3. The approximate dimensions are 75 millimetres in height, and 8.4 metres in length.
